

# Q1 Are you a resident of Brunswick County?



### Q2 What part of the county do you live in?





# Q4 Do you smoke/or use smokeless tobacco products regularly (daily)?



# Q5 Does someone in your immediate family smoke or use smokeless tobacco products regularly (daily)?












# Q15 Do you consider vaping/using an electronic cigarette to be in the same category as smoking or using tobacco products?


