## **BRUNSWICK CONNECTOR AGREEMENT BETWEEN** CAPE FEAR PUBLIC TRANSIT AUTHORITY and THE BRUNSWICK CONSORTIUM ADDENDUM 1

WHEREAS on June 20, 2013, the Cape Fear Public Transportation Authority ("Authority") and Brunswick County, North Carolina; the Town of Leland, North Carolina; and the Town of Navassa, North Carolina, collectively referred to as the Brunswick Consortium ("Consortium"), entered into an agreement for funding the Brunswick Connector, a public transportation route operated by the Authority in the Wilmington urbanized area; and

WHEREAS, the parties mutually agree to continue route 204 from July 01, 2020 through June 30, 2021; and

WHEREAS, the previously funded vehicle has sufficient remaining useful life to waive any capital contributions in FY 2021;

**NOW, THEREFORE**, in consideration of the foregoing and their mutual covenants hereinafter set forth, the AUTHORITY and Brunswick County, North Carolina; the Town of Leland, North Carolina; and the Town of Navassa, North Carolina, collectively referred to as the Brunswick Consortium agree to support and fund Wave Transit Route 204 identical to FY 2020 as follows:

- 1. Section 2 Annual Budget Appropriation Funding for FY 2021 July 01, 2020 through June 30, 2021
  - Town of Leland \$54,636
  - Town of Navassa \$13,687
  - Brunswick County \$32,072
  - Authority \$160,000
- 2. Section 6 Duration

The term of the addendum shall begin on July 01, 2020 and terminate on June 30, 2021.

## Notwithstanding the foregoing, all remaining terms in the Contract remain in full effect
