### FIRST AMENDMENT TO GOODS AND SERVICES AGREEMENT

WHEREAS, additional audio/visual needs or modifications have been requested or identified, including the additions of a 65" display at Console 0, wireless content distribution to conference room, wireless control for mobile system operation within facility, auto-tracking camera to conference room, conference table HDMI distribution, control room PCs USB extension, and the upgrade of nine (9) touch panels from seven (7) to ten (10) inch screens; and

WHEREAS, the additional audio/visual equipment, peripherals, and installation services associated with same resulted in additional costs and fees other than those set forth in the Agreement.

NOW, THEREFORE, in consideration of the mutual covenants and agreements as set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

- 1. The Proposal for the additions of a 65" display at Console 0, wireless content distribution to conference room, wireless control for mobile system operation within facility, autotracking camera to conference room, conference table HDMI distribution, control room PCs USB extension, and the upgrade of nine (9) touch panels from seven (7) to ten (10) inch screens is attached hereto as Exhibit "A." The Exhibit is hereby incorporated by reference and made an integral part of the Agreement, as amended.
- 2. Except as otherwise amended herein, all other terms of the Agreement shall remain in full force and effect.
- 3. This First Amendment may be executed in one or more counterparts, each of which shall be deemed an original and all of which shall be considered one and the same. This First Amendment may also be executed electronically. By signing electronically, the parties indicate their intent to comply with the Electronic Commerce in Government Act (N.C.G.S § 66-358.1 et seq.) and the Uniform Electronic Transactions Act (N.C.G.S § 66-311 et seq.). Delivery of an executed counterpart of this First Amendment by either electronic means or by facsimile shall be as effective as a manually executed counterpart.
