**RESOLUTION AUTHORIZING PURCHASE OF

WHEREAS, N.C.G.S 143-129(e)(6), Procedure for Letting of Public Contracts, allows for the waiver of formal bidding requirements for purchases of apparatus, supplies, materials, or equipment when performance or price competition for a product are not available, or a needed product is available from only one source of supply, or standardization or compatibility is the overriding consideration; and

WHEREAS, The Public Utilities Department utilizes numerous products in the day-to-day operation of water and sewer systems. In most cases, there are multiple manufacturers that can provide competitive products that allow our Utilities Purchasing Manager the opportunity to receive multiple bids in compliance with state and county procedures. However, there are occasions when specific items are only available from an exclusive vendor and price competition is not available. Some existing processes are proprietary and replacement parts must be purchased from a specific manufacturer; and

WHEREAS, the attached list specifies manufactures/vendors used by the Utilities Department that are the sole source for the specific product indicated. Staff requests the Board approve the vendors and products on the accompanying list as sole source purchases under the exemption referenced in NCGS 143-129 (e) (6); and

WHEREAS, the governing board must approve the purchase under this bidding exemption prior to awarding the contract.



Approve declaring Air Vac as the sole source provider of equipment for the Sunset Beach Island Vacuum Pump Station and authorizing the County staff to negotiate the purchase of the equipment from Air Vac.

BACKGROUND/PURPOSE OF REQUEST:

With the decision that a vacuum collection system was the most cost-effective type of collection system for the Sunset Beach Island, there is only one major supplier of vacuum collection system equipment. Air Vac is equipment supplier to all of the vacuum collection systems constructed in Brunswick County and North Carolina and is the only supplier of vacuum sewer collection system equipment that meets the specifications for number of systems currently installed, proven reliability, and maintenance support.

The County is preparing to bid the construction of the Sunset Beach Island Collection System and construction of the Vacuum Pump Station. The County has two options on purchasing the equipment from Air Vac. The first option is to include purchase of the equipment in the construction contract and the contractor will be responsible for negotiating a price with Air Vac. The second option is for the County to negotiate a price with Air Vac and supply the equipment to the contractor.

If the contractor negotiates the price with Air Vac, most contractors will add 10 -15% to cost of the equipment for overhead and profit. In this case, this would add approximately \$100,000 to \$150,000 to the cost of the project. If the County purchases the equipment, the County saves the overhead and profit cost but is now responsible for providing the equipment to the contractor in a timely manner. There is some risk of having to store the equipment until the contractor is ready.

County staff recommends that Air Vac be approved as the sole source for the vacuum collection system including the valve pits and Vacuum Pump Station. County staff also recommends that the County negotiate with Air Vac for the purchase of the equipment associated with the Vacuum Pump Station. The contractor would be responsible for negotiation of the price on the valve pits.



The budget price for the vacuum station equipment is \$425,000. This includes the raw sewage pumps, vacuum pumps, the tank, valving inside the building, electrical panels, including starters, and instrumentation and controls, and miscellaneous accessories. Budget price for the valve pits would be \$2,317,000. This includes the valve pit and the vacuum valve for 662 pits. If CG&L decides to use the breather unit rather than the candy cane, and if the County elects to use the breather unit, the additional cost would be approximately \$113,000.

The breather unit looks like a telephone box and is mounted on the gravity line to the pit at the property line. The candy cane is generally located at the side of the house, and is installed by the property owner. The State may require the candy cane in order to have the system above the 100-year flood. Oak Island used both approaches, but had to use the candy canes where the 100-year flood would submerge the breathers.

It is possible that AirVac may allow a 2% to 3% discount on the valve pits. Oak Island ended up getting this discount, but probably should use the numbers I provided above for now.

When ready, the County will need to negotiate a final price and terms and conditions with Rich Naret, who is a VP of AirVac, and Ron White. Both can be reached at 813-855-6297 in AirVac's Tampa office.

As mentioned to you previously, AirVac is the only manufacturer and supplier in the US for vacuum systems. There is one other manufacturer, but they are overseas. AirVac is American made.

Sorry I did not get to you to sooner, I needed to confirm the type and size of the valve pits we are designing around for this project. Just received that information this morning.

Approve agreement with Sensus USA for the purchase of an Advance Meter Infrastructure System to replace the existing manual meter reading system. The estimated total cost of the cost of the project is \$9,511,415.93 which will be spread over a 6-year period. The first year cost will be \$1,386,000.

BACKGROUND/PURPOSE OF REQUEST:

The County has considered implementation of an automated meter reading system for a number of years. Funds were included in this year's Capital Improvement Program for implementation of an automated meter reading system. A Meter Reading Committee was established, which consisted of Public Utilities staff, Finance staff and Commissioner Norris. The committee met to determine the types of systems that should be considered and a Request for Information and Qualifications (RFIQ) was developed. The RFIQ was sent to all of the leading meter manufacturers that serve our area.

The County received responses from seven meter manufacturers. The committee evaluated all of the responses from the vendors. Most of the vendors provided information on two types of automated meter reading systems. The first type is the AMR or drive by type of system where a customer service employee must drive by the meter in order to receive a reading on manufacturer supplied equipment. This is the type system that we currently use in the Sunset Beach area. The second type of system is the AMI type system where the readings are transmitted back to central receiving point, i.e. the Customer Service Office.

After much discussion, the committee narrowed the number of meter vendors from seven to four. Those four were asked to provide a more detailed proposal on both systems including costs of installation and equipment. After hearing presentations from all four vendors, the committee narrowed the selection to two firms. The committee selected the AMI type system as the best type of system and detailed and final pricing was sought from AMCO Meters and Sensus Meters. After evaluation of the detailed and final pricing Sensus was selected as the best firm to provide the equipment, software, and installation service for the new meter reading system.

During the evaluation process, County staff determined that most utilities installed a new metering system over a period of years instead of all at one time. Also, the County staff determined that County employees could install the meters under supervision of Sensus.

During the detailed and final price negotiations, Sensus made a number of offers to Brunswick County related to price and services that are to be provided. The purpose of this agreement is to consolidate all of the prices, offers of service from Sensus and County responsibilities into one document. This agreement clearly indicates that the project will be phased over a 6-year period and that the County will only purchase equipment and services if funds are budgeted.

County staff recommends approval of the selection of Sensus for provision of the equipment and

service associated with installation of the meter reading system and approval of the agreement with Sensus outlining the offers and services to be provided by Sensus.

4.1.4 Storage of samples for microbiological analysis

Although recommendations vary, the time between sample collection and analysis should, in general, not exceed 6 hours, and 24 hours is considered the absolute maximum. It is assumed that the samples are immediately placed in a lightproof insulated box containing melting ice or ice-packs with water to ensure rapid cooling. If ice is not available, the transportation time must not exceed 2 hours. It is imperative that samples are kept in the dark and that cooling is rapid. If these conditions are not met, the samples should be discarded. When water that contains or may contain even traces of chlorine is sampled, the chlorine must be inactivated. If it is not, microbes may be killed during transit and an erroneous result will be obtained. The bottles in which the samples are placed should therefore contain sodium thiosulfate to neutralize any chlorine present, as de-

In years past we have put the Sodium Chlorite contract out to bid but had very little response outside of our current vendor SMS Enterprises. This contract is not a typical bulk chemical supply contract as the vendor has to supply the equipment that also produces the desired end product, Chlorine-dioxide. This equipment is integrated into the existing facility and is a key component in the production of a disinfectant that is needed to ensure the drinking water is safe. If we went to bid as often as the other bulk chemicals no one would even bid on it as the mobilization of the equipment would make it cost prohibitive. That being said, I do keep tabs on what other facilities like ours have to pay for the base product sodium chlorite. Davidson County uses sodium chlorite with vendor supplied equipment and their current price is \$0.90 per lb. Harnett County uses sodium chlorite but has made the capital investment and purchased their feed equipment and their cost is \$0.57 per lb. At our current price of \$0.75 per lb. we pay about an \$18,000 per year premium to use the vendor supplied equipment which has a value of \$240,000 (3 machines X \$80,000). However the vendor is responsible for maintenance supplies, repairs, and weekly site visits to ensure the equipment is functioning properly.
